- 3. Epworth has no obligation to inform applicants that their application was received subject to any of the errors or omissions listed above.
- 4. It is the responsibility of the Epworth Sponsor to help assure these rules have been observed.
- 5. Once submitted, applications cannot be returned.


The application process will remain open through April 30, 2022.

Only an Epworth Sponsor can submit an application to the Committee. Epworth's Sponsor should fill in Part I of this application.

The relationship between the "Epworth Sponsor," the "Grantee" and "Beneficiary Recipient(s)" is shown in the following figure.



An Epworth Sponsor is any member of Epworth United Methodist Church, and is:

- 1. responsible for the application to recommend a potential Grant Recipient or Grantee;
- 2. Epworth's point of contact with the Grantee for the purposes of the proposed gift;
- 3. adequately informed with respect to the Grantee's history, origin, purpose, effectiveness, integrity and past performance;

- 4. knowledgeable in detail with respect to how the Grantee will put Epworth's distribution to work;
- 5. accountable to Epworth's congregation in terms of the impact of Epworth's donation to the Grantee;
- 6. responsible for obtaining a written acknowledgement and report from the Grantee as to how Epworth's donation was actually spent to be provided to the Committee in a timely manner.

That is to say, Epworth's Sponsor should have a very close, and not an arm's-length, relationship with the proposed Grantee, for example:

- 1. Do you know the Grantee personally?
- 2. Have you actually worked with Grantee before for charitable purposes?

What does "Inside Epworth" and "Outside of Epworth" Mean?

Grant money from Epworth's endowment funds can be for purposes inside (or internal to) Epworth or outside of (or external to) Epworth. Typically, "inside Epworth" means beneficiary recipients are associated directly with Epworth. A grant to help Epworth's youth or a grant to pay for equipment used by Epworth's membership, are examples of grants inside Epworth. "Outside of Epworth" consists of everything which is not inside Epworth. Note, however, that Epworth may be a Grant Recipient without Beneficiary Recipients being directly associated with

Epworth - for example, a grant is given to Epworth to be used for a particular mission in Zimbabwe. "Local" as used herein means geographically "within 10 miles of Epworth.
